**On February 18, 2026, at 4:00 p.m.**, the Cape Cod Regional Government (Barnstable County) Assembly of Delegates will hold a hybrid (in-person and virtual) public hearing on Proposed Ordinance 2026-05, To authorize the appropriation and Transfer of \$347,731 from the Capital Stabilization Fund for the First District Courthouse chiller underground piping replacement project. The public hearing will be held in the Mary Pat Flynn Conference Center at the Barnstable County Courthouse Complex, 3195 Main Street – Route 6A, in the town of Barnstable, and via Microsoft Teams. The hearings will be open to anyone wishing to testify or make public comment on the proposed ordinances. The full text of the proposed ordinance has been electronically distributed to the Town Clerk of each town in Barnstable County and is also available on the Cape Cod Regional Government website. Proposed Ordinance No. 5**

1 To authorize the appropriation and Transfer of \$347,731 from the Capital Stabilization Fund  
2 for the First District Courthouse chiller underground piping replacement project.

3 ***The Cape Cod regional government, known as Barnstable County, hereby ordains;***

4 SECTION 1. That the sum of Three Hundred Forty-Seven Thousand Seven Hundred Thirty-One  
5 Dollars (\$347,731) be appropriated for the purpose of funding a change order associated with  
6 the First District Courthouse Chiller Replacement Project, specifically for the replacement of  
7 deteriorated underground chilled water piping, including related excavation, materials,  
8 installation, testing, and associated contingency

9 SECTION 2.

10 That to meet this appropriation, the sum of \$347,731 be transferred from the Capital  
11 Stabilization Fund.

12 SECTION 3.

13 This appropriation is declared to be of an emergency nature, as the existing underground  
14 chilled water piping serving the First District Courthouse was discovered to be in a severely  
15 deteriorated condition during the installation of a replacement exterior chiller, rendering  
16 connection to the existing system infeasible and jeopardizing the timely operation of the  
17 courthouse cooling system. Immediate action is required to ensure the chiller system is  
18 operational prior to the 2026 cooling season and to maintain safe and functional conditions  
19 within the courthouse facility.

1 SECTION 4.

2 Under the existing lease agreement with the Massachusetts Trial Court, this project is  
3 anticipated to be ninety-seven percent (97%) reimbursable, subject to approval and final  
4 reconciliation.
