A subcommittee of the Cape Cod Commission will hold a virtual public hearing on the following Project on **Monday, March 2, 2026 at 5:00 p.m.** (continued from Monday, February 2, 2026). The Project has been referred to the Cape Cod Commission as a mandatory Development of Regional Impact (DRI) pursuant to Sections 12 & 13 of the Cape Cod Commission Act, as amended. At the hearing, the Commission will hear testimony, discuss the project and may then vote on the Project.

**Project Description:** The Project proposes installation of a new personal wireless service facility including a 130 ft tall monopole tower and associated ground equipment.
