### HYBRID PUBLIC HEARING NOTICE CAPE COD COMMISSION

The Cape Cod Commission will hold a hybrid public hearing on the following Project on **Thursday, March 5, 2026 at 3:00 p.m. in person** (continued from February 12, 2026) (at the Mary Pat Flynn Conference Room, 3195 Main Street, Barnstable, MA 02630) **and virtually** (online and by telephone). The Project has been referred to the Cape Cod Commission as a mandatory Development of Regional Impact (DRI) pursuant to Sections 12 & 13 of the Cape Cod Commission Act, as amended. At the hearing, the Commission will hear testimony, discuss the project and may then vote on the Project.

**Project Description:** The project proposes to redevelop the former police station property into a 40-unit home-ownership residential development, including below market value units. The project proposes to construct a new 4-story building of approximately 30,000 square feet and associated site improvements.
