The Cape Cod Commission will hold a hybrid public hearing on the following Project on **Thursday, March 19, 2026 at 3:00 p.m.** in person (at the Mary Pat Flynn Conference Room, 3195 Main Street, Barnstable, MA 02630) and virtually (online and by telephone) to consider the following Development of Regional Impact (DRI) Exemption request submitted pursuant to Section 12(k) of the Cape Cod Commission Act and Section 7 of the Enabling Regulations Governing Review of Developments of Regional Impact, as amended. At this hearing, the Commission will assemble the record, review the proposed development, discuss the following project and may decide and vote on whether the project qualifies for a DRI Exemption.
