Barnstable County HOME Consortium Five Year Consolidated Plan 2025-2029 Annual Action Plan for Program Year 2025

The Barnstable County HOME Consortium has prepared its draft Five Year Consolidated Plan for Program Years 2025-2029 (July 1, 2025 through June 30, 2030) and its draft Annual Action Plan for Program Year 2025 (PY25) (July 1, 2025 through June 30, 2026). The consolidated planning process serves as a framework for a community-wide dialogue to identify housing and community development priorities that align and focus funding from federal block grant programs. The Consolidated Plan is updated every five years and includes citizen participation efforts and a Citizen Participation Plan, a Needs Assessment, Market Analysis, Strategic Plan, and accompanying Annual Action Plan. This process and the resulting plans outline funding priorities and serve as the strategic and planning documents for Barnstable County's HOME Program which is funded by the U. S. Department of Housing and Urban Development (HUD). The anticipated HUD allocation for PY25 Annual Action Plan is \$400,000.00 and approximately \$39,665.60 in repurposed program income. The anticipated funding amount for the following four Program Years is \$400,000.00 per year plus any repurposed program income.
