The HOME Consortium was awarded \$404,489.63 in federal funds from the U.S. Department of Housing and Urban Development (HUD) to carry out the goals and objectives set forth in the HOME Program's 2020-2024 Consolidated Plan and 2024 Annual Action Plan. The CAPER is a year-end report that outlines the accomplishments and challenges of the Barnstable County HOME Program.
