SYNOPSIS

Project Title: Restoration of Historic Entrance Columns

The Cultural Center of Cape Cod seeks CPA funding to replace two original, severely deteriorated wooden columns at the primary entrance of its historic Bass River campus building. Constructed in the early 20th century as a bank, the building is now a cornerstone of cultural life in Dennis and greater Cape Cod. These columns are integral to the façade and identity of the structure, and have suffered extensive rot from age and exposure. Restoration will be conducted using historically appropriate materials and methods, preserving both the architectural character and public safety. The completed work will be publicly visible and contribute to the long-term preservation of this iconic building.

PROJECT INFORMATION

Project Concept:

This project will replace two deteriorated structural columns and restore supporting portico at the main entrance of the Cultural Center's historic building. The columns are essential architectural elements and require exact-match replication using traditional materials.

- Ensure safe access for the public
- Restore original historic design integrity
- Support continued use of a public cultural facility

Project Cost: \$14,816

Description: Replace (2) existing columns on the front entry, installing (2) new poured piers with mechanical connections to support the overhang.

Scope of Work:

1. Apply for and receive Town permit approval: Town of Yarmouth Building Department.
2. Prepare for construction process: Provide onsite waste management; contractor trailer and jobsite toilet.
3. Frame Phase: Construct/Install/Apply:
 - a. Frame:
 - i. Provide temporary support to the existing entryway.
 - ii. Remove the existing columns (two supports on the exterior of the entryway).
 - iii. Remove the existing steel plates and granite slab.
 - iv. Provide (2) poured concrete sonotubes (16" wide) with threaded rod for mechanical fastening of the new posts/columns.
 - v. Reset the granite slab.
 - vi. Install (2) new columns and tie-into the existing trim.
 - b. Exterior Trim: Tie-in/replacement and repair may be required depending on the condition of the existing trim above/around the column connections and requirements for mechanical connection for code compliance. Any new exterior trim installed will be Azek trimboard, applied with stainless steel fasteners.
4. Paint: Exterior: (Entire Exterior Facade and Entry Door): Seal, caulk, fill all nails/screw holes. Exterior trim to receive (2) coat mildewcide latex finish.
5. Clean the area of waste.
6. All waste to be removed by contractor trailer.



Owner Advisements: The following areas are for your review. The Project Cost Breakout follows with additional project cost details. Allowances are offered for materials and finishes which require a final product selection, have estimated time and materials, or for materials which may be subject to price changes based on current market availability.

1. Landscaping: Finish landscaping is provided as an allowance to re-finish the surrounding planting beds as needed; topsoil, mulch, and foundation plantings.
2. Engineering: (1) Hour of Structural Engineering is included pending site/column review for installation.
3. Allowances: In the following Project Cost Breakout allowances are identified for cost planning.

Philbrook Construction is a fully licensed and insured general contractor. All proposed work will be properly permitted and documented with the associated Town of record. All subcontractors will be fully licensed and insured.

As supporters of the arts and active members of the Dennis community, we believe this is a highly worthy project that will have broad and lasting benefits.


