**1. PUBLIC HEARINGS:**

- I. **Section 4.9 Zoning Bylaw Update (Continued from March 2, 2026):** To see if the Town of Dennis will amend the Dennis Zoning By-Laws by Amending the following Section: 4.9 - Provisions to encourage the Development of Affordable Housing in Dennis. The purpose of the proposed amendments is twofold: To clarify and re-order the sub-sections, add headers, descriptions and definitions, remove obsolete words, correct changed names and clarify the different methods; consider some substantive changes to increase the creation of affordable housing in appropriate locations near services, transportation and sewer. The continued public hearing is to refine revised draft amendments to 4.9 and see if the Planning Board will recommend the proposed changes to the Annual Town Meeting in May 2026.
- II. **180 SOUTH YARMOUTH ROAD (2720):** 3 P Properties, LLC, 665 Church Street, Whitinsville, MA 01588 C/O Eliza Cox, is seeking a Modification of a Special Permit to extend the approved retail lumber/hardware use at 243 Route 6A to Koopman Lumber's adjacent parcel at 180 South Yarmouth Road. Located in the Limited Business Zoning District and the Old Kings Highway Historic District at 180 South Yarmouth Road, Dennis MA (Map 255, Parcel 4).
